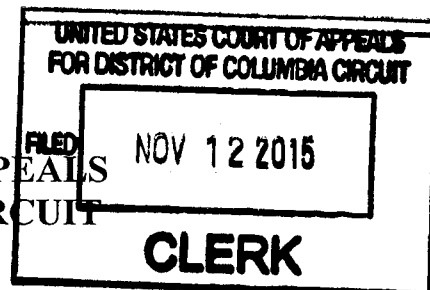

Pursuant to Rule 26.1 of the Federal Rules of Appellate Procedure and Circuit Rule 26.1, Petitioner Entergy Corporation (“Entergy”) makes the following declarations:


Entergy Corporation is a publicly traded company (symbol: ETR) incorporated in the State of Delaware, with its principal place of business in the city of New Orleans, Louisiana. Entergy does not have any parent companies that have a 10 percent (10 %) or greater ownership interest in Entergy. 
