ORDER: This matter is before the Court on Defendants' Emergency Motion for a Temporary Stay of Execution of the Remand Order [81]. Yesterday evening this Court entered its Order [80] denying Defendants' earlier Motion to Stay Order on Motion to Remand [75]. In this Order the Court based its decision to deny the original Motion to Stay on the grounds that Defendants had failed to show a likelihood of success on the merits, or an irreparable injury, or that other factors weighed in favor of a stay. The Defendants' Motion now before the Court is a Motion for Reconsideration of that Order in all but name only. Defendants fail, however, to advance in the instant Motion any grounds warranting a reconsideration of the Court's prior Order, including no reference to an intervening change in the controlling law, no citation to new evidence previously unavailable, or the need to correct clear error or prevent manifest injustice. See Servants of Paraclete v. Does, 204 F.3d 1005, 1012 (10th Cir. 2000). For these reasons the Defendants' Emergency Motion for a Temporary Stay of Execution of the Remand Order [81] is DENIED.
