**JOINT STIPULATION TO
 STAY PROCEEDINGS FOR 60
 DAYS AND ~~PROPOSED~~
 ORDER**

22 Pursuant to Civil Local Rule 7-12 and 16-2, Federal Defendants and
 23 Plaintiffs in the three related cases of *Center for Biological Diversity v. de la Vega*,
 24 No. 19-cv-05206, *California v. de la Vega*, No. 19-cv-06013, and *Animal Legal Def.*
 25 *Fund v. de la Vega*, No. 19-cv-06812, stipulate to a stay of proceedings for 60 days.

1 Intervenor-Defendants do not join in the stipulation, but do not oppose the request
2 for relief. In support of the joint stipulation, the Federal Defendants and Plaintiffs
3 set forth the following reasons:

4
5 1. These related cases¹ challenge three Endangered Species Act (“ESA”) final
6 rules promulgated by the U.S. Fish and Wildlife Service within the U.S.
7 Department of the Interior, two of which were jointly promulgated with the
8 National Marine Fisheries Service within the National Oceanic and Atmospheric
9 Administration, U.S. Department of Commerce. *See* 84 Fed. Reg. 45020 (Section 4
10 revisions); 84 Fed. Reg. 44753 (Section 4(d) revisions); and 84 Fed. Reg. 44976
11 (Section 7(a)(2) revisions).
12

13 2. On November 19, 2020, the Court entered an amended case management
14 order. ECF 111. In accordance with that order, plaintiffs filed their motions for
15 summary judgment on January 19, 2021. ECF 86; ECF 116; ECF 130.
16

17 3. Pursuant to the Court’s amended case management order, Federal
18 Defendants’ combined cross motion for summary judgment and opposition to
19 Plaintiffs’ motions for summary judgment is due on March 19, 2021. Intervenor-
20 Defendants’ combined cross motions for summary judgment and oppositions to
21 Plaintiffs motions for summary judgment are due on April 9, 2021. ECF 111.

26 ¹ On January 27, 2021, the Court related *State of California v. de la Vega*, 21-cv-
27 00440-JST (N.D. Cal.) with the above-related cases. ECF 136. Federal Defendants
and State-Plaintiffs in that case will be filing a similar stipulated motion.

1 4. On January 20, 2021, President Biden issued an Executive Order entitled
2 “Executive Order on Protecting Public Health and the Environment and Restoring
3 Science to Tackle the Climate Crisis.” In conformance with the Executive Order,
4 Federal Defendants are reviewing many rules promulgated in the last four years,
5 including the final rules at issue in this case.

7 5. Agencies have inherent authority to review past decisions and to revise,
8 replace, or repeal a decision to the extent permitted by law and supported by a
9 reasoned explanation. *FCC v. Fox Television Stations, Inc.*, 556 U.S. 502, 515
10 (2009); *Motor Vehicle Mfrs. Ass’n v. State Farm Mutual Auto. Ins. Co.*, 463 U.S. 29,
11 42 (1983) (“*State Farm*”); *Sierra Club v. Van Antwerp*, 560 F. Supp. 2d 21, 23
12 (D.D.C. 2008). An agency’s interpretation of a statute it administers is not “carved
13 in stone” but must be evaluated “on a continuing basis,” for example, “in response to
14 . . . a change in administrations.” *Nat’l Cable & Telecomm. Ass’n v. Brand X*
15 *Internet Servs.*, 545 U.S. 967, 981 (2005) (internal quotation marks and citations
16 omitted).

19 6. Federal Defendants and Plaintiffs request a stay of proceedings for 60 days to
20 give appropriate officials adequate time to review the final rules and determine how
21 they would like to proceed with this litigation. Accordingly, Federal Defendants
22 and Plaintiffs respectfully request that the Court enter an order staying this case
23 for a period of 60 days and vacating the deadlines in the amended case management
24 order. At the end of the stay, the Parties will provide a joint status report proposing
25 further proceedings.

1 7. Granting this motion will not prejudice any party, will conserve the Parties'
2 resources, and will promote the interest of judicial economy.

3 For the foregoing reasons, the Parties respectfully request that the Court
4 stay this case for 60 days and vacate the remaining deadlines. Upon expiration of
5 the stay, the Parties will file a joint status report proposing further proceedings.


