
Pursuant to Fed. R. App. P. 15 and Clean Air Act section 307(b)(1), 42 U.S.C. § 7607(b)(1), American Forest & Paper Association, Inc. and American Wood Council hereby petition this Court to review a final rule promulgated by the U.S. Environmental Protection Agency entitled “Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units; Final Rule,” published at 80 Fed. Reg. 64,662 on October 23, 2015, (EPA Docket No. EPA-HQ-OAR-2013-0602) (the “Emission Guidelines”).

In particular, petitioners are filing this action to address provisions of the Emission Guidelines that describe how state plans under Clean Air Act section 111(d), 42 U.S.C. § 7411(d), should deal with potential generation of electricity through combustion of biomass-based fuels.
