Plaintiffs respectfully submit this Notice of Errata to its proposed Pretrial Order, filed on October 15, 2018 (Doc. 383), in order to correct an inadvertent error. After receiving correspondence from the Defendants, Plaintiffs discovered that they inadvertently included the Defendants in the following sentence at the beginning of the Proposed Pretrial Order:

Pursuant to Fed. R. Civ. P. and LR 16-5, Plaintiffs Kelsey Cascadia Rose Juliana, et al. (“Plaintiffs”), and Defendants United States, et al. (“Defendants”) by and through their undersigned counsel respectfully submit the following Proposed Pretrial Order.

Doc. 383 at 2. That sentence should be replaced with the following sentence:

Pursuant to Fed. R. Civ. P. and LR 16-5, Plaintiffs Kelsey Cascadia Rose Juliana, et al. (“Plaintiffs”), by and through their undersigned counsel, respectfully submit the following Proposed Pretrial Order.

Plaintiffs did not mean to suggest to the Court that the Pretrial Order was a joint filing and thus should have deleted reference to the Defendants in the first sentence, but inadvertently neglected to do so. In addition, in an abundance of caution and to make it clear that Defendants have not stipulated to any facts, Plaintiffs have replaced the term “Parties” with “Plaintiffs” and added the following footnote to the “Agreed Facts” section of the Pretrial Order:

Based on their refusal to confer with the Plaintiffs on the Proposed Pretrial Order, the Defendants have not stipulated to the facts set forth in this section. This section constitutes Plaintiffs’ position as to the agreed facts in this case.

Otherwise Plaintiffs made no other changes to Plaintiffs’ Proposed Pretrial Order.
