**JOINT STIPULATION TO STAY CASE  
FOR 120 DAYS**

1 Pursuant to Civil L.R. 6-1(a), defendants the Bureau of Land Management and Debra  
2 Haaland, in her official capacity as Secretary of the United States Department of the Interior  
3 (collectively, “Defendants”), and plaintiffs Center for Biological Diversity, Sierra Club, County of  
4 Santa Cruz and County of Monterey (collectively, “Plaintiffs”), having conferred through their  
5 respective counsel, hereby stipulate to request that the Court stay this case for 120 days. This stay  
6 will allow for the parties to initiate and participate in settlement discussions.

7 This is the sixth extension sought in this case. The first extension was to allow Plaintiffs to  
8 file an amended complaint; the second was to allow Defendants additional time to lodge the  
9 administrative record; the third was to allow the parties to complete the administrative record  
10 without further motions; the fourth was to allow for Defendants’ internal review of the case; and the  
11 fifth was to allow for Defendants to continue that review.

12 The parties respectfully request that the deadlines in the case be stayed until October 20,  
13 2021. Should further litigation be necessary, the parties will provide the Court with a proposed  
14 briefing schedule by October 20, 2021.
