



case that the parties have agreed to entry of this Agreed Judgment and Permanent Injunction.

Based upon the evidence presented and the parties' agreement:

IT IS ORDERED, ADJUDGED AND DECREED that a permanent injunction be immediately issued restraining Defendants and their agents, servants, employees and attorneys, and those persons in active concert or participation with one or more of them who receive actual notice of this Agreed Judgment and Permanent Injunction by personal service or otherwise from:

- (i) interfering with, preventing, obstructing or otherwise infringing, in any way, with Keystone's use and enjoyment of any easement, right-of-way, lease or other property interest in Texas or Oklahoma (collectively "Keystone Property") including, without limitation, trespassing on or physically occupying Keystone Property in any manner to interfere with, prevent or obstruct Keystone from undertaking construction activities or otherwise exercising its rights of use and possession of Keystone Property; provided, however, this injunction shall not prevent Defendants from passing over and/or crossing any public road in which Keystone has a right to cross;
- (ii) interfering with, preventing, obstructing or otherwise infringing, in any way, with Keystone's use and enjoyment of any equipment, construction materials or facility that is within the Keystone Property or that is otherwise identified by a sign, logo or other marking sufficient to give notice that such equipment, construction materials or facility is owned by, or operated on behalf of, Keystone or one of its affiliates, contractors or subcontractors (including, but not limited to, Michels Corporation) (collectively "Keystone Equipment"), including, without limitation, trespassing on, physically occupying, tortiously or illegally interfering with and/or disabling Keystone Equipment, or chaining, shackling, binding or attaching a person's body or any other object, article or mechanism to Keystone Equipment to immobilize, stop, halt or arrest Keystone Equipment or construction activities or operations on Keystone Property;
- (iii) directly and purposefully barricading, blocking or preventing access to or ingress and egress from Keystone Property and/or Keystone Equipment; or
- (iv) directly committing or threatening the civil tort of assault and/or battery against any obvious employee or visitor of Keystone or one of its affiliates, contractors or subcontractors (including, but not limited to, Michels Corporation).

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the District Clerk of Wood County, Texas, shall immediately remit to Keystone, by and through its counsel of record, Zabel Freeman, 420 Heights Boulevard, Houston, Texas 77007, the funds on deposit in the registry of the Court, posted by Keystone as bond for issuance of the temporary restraining order.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each party shall bear their own respective attorneys' fees and costs of Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the District Clerk of Wood County, Texas, shall forthwith issue a permanent injunction in conformity with the law and the terms of this Agreed Judgment and Permanent Injunction, which shall be effective as of the date same is signed.

All relief as to Defendants not granted herein is expressly denied.
