PETITION FOR REVIEW

Pursuant to Federal Rule of Appellate Procedure 15(a) and Clean Air Act § 307(b)(1), 42 U.S.C. § 7607(b)(1), GenOn Mid-Atlantic, LLC; Indian River Power

LLC; Louisiana Generating LLC; Midwest Generation, LLC; NRG Chalk Point LLC; NRG Power Midwest LP; NRG Rema LLC; NRG Texas Power LLC; NRG
Wholesale Generation LP; and Vienna Power LLC hereby petition this Court for review of a nationally applicable rule of respondent the United States Environmental Protection Agency. The Agency adopted the final rule, "Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units," on August 3, 2015, and it was published in the Federal Register on October 23, 2015. 80 FR 64662 (Oct. 23, 2015). Respondents issued this rule pursuant to Clean Air Act § 111(d), 42 U.S.C. § 7411(d); it is to be codified in 40 C.F.R. Part 60, subpart UUUU.

Petitioners seek review of the final rule on the grounds, *inter alia*, that portions (or possibly all) of the rule are arbitrary and capricious, contrary to the United States Constitution and the Clean Air Act and regulations promulgated thereunder, and otherwise contrary to law. Petitioners request that this Court hold unlawful, vacate, enjoin, and set aside portions (or possibly all) of the final rule, and that the Court provide such additional relief as may be necessary and appropriate.


