**JOINT STATUS REPORT**

Pursuant to this Court's order of March 1, 2016, Petitioner Compsys, Inc. ("Petitioner"), and Respondent, the Environmental Protection Agency ("EPA"), report as follows on the status of this matter:

1) This case comprises a challenge to an EPA rulemaking issued at 80 Fed. Reg. 42,870 (July 20, 2015), entitled "Protection of Stratospheric Ozone: Change of Listing Status for Certain Substitutes Under the Significant New Alternatives Policy Program." In addition, Compsys, Inc. ("Compsys") filed an administrative petition for reconsideration of the final action with EPA on September 18, 2015.

2) On October 22, 2015, Compsys submitted an unopposed motion to hold this matter in abeyance pending the completion of EPA's consideration of

Compsys' administrative petition for reconsideration and any potential administrative reconsideration proceedings. On October 30, 2015, the Court issued an Order granting the Compsys' motion and instructing the Parties to file joint status reports with the Court at 60-day intervals thereafter.

3) On February 23, 2016, Compsys submitted an unopposed motion to continue to hold this matter in abeyance pending the completion of EPA's consideration of Compsys' administrative petition for reconsideration and any potential administrative reconsideration proceedings. On March 1, 2016, the Court granted the motion and issued an order continuing to hold in abeyance Case No. 15-1334 until February 22, 2017.

4) EPA is still considering the merits of Compsys' administrative Petition for Reconsideration and expects to take final action resolving the issues raised in the petition no later than February 22, 2017.

5) The parties will continue to update the Court regarding the status of agency proceedings at 90-day intervals, as instructed in the Court's Order of March 1, 2016.
