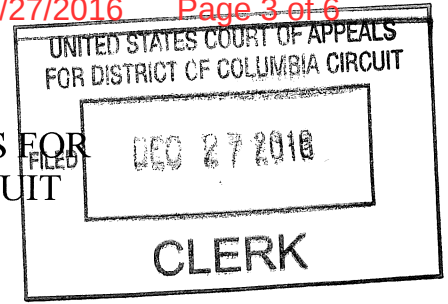


RULE 26.1 STATEMENT


