# SUPPLEMENTAL DECLARATION OF ANDREA K. RODGERS

In Support of Plaintiffs' Reply in Support of Motion *in Limine* Seeking Judicial Notice of Federal Government Documents

- I, Andrea K. Rodgers, hereby declare and if called upon would testify as follows:
  - 1. I am an attorney of record in the above-entitled action. I make this Declaration in support of Plaintiffs' Reply in Support of Motion *in Limine* Seeking Judicial Notice of Federal Government Documents. I have personal knowledge of the facts stated herein, except as to those stated upon information and belief, and if called to testify, I would and could testify competently thereto.
  - 2. I submit this Supplemental Declaration in light of correspondence that we have received from the Defendants *after* Plaintiffs filed their Reply Brief. A true and correct copy of the correspondence is attached as **Exhibit 1** to this Declaration.
  - 3. Based upon the additional foundational information Plaintiffs provided to Defendants in advance of filing the Reply Brief, Defendants have now changed their position on 24¹ exhibits. *See* Exhibit 1 at 2. Plaintiffs note that this information was provided to the Defendants in advance of the filing of the Reply Brief in an attempt to meet and confer on the matter to resolve Defendants' outstanding objections. Defendants failed to respond to this additional foundational information in a timely manner and neglected to answer Plaintiffs' repeated requests to meet and confer to resolve Defendants' objections. *See* Declaration of Andrea K. Rodgers in Support of Plaintiffs' Reply in Support of Motion *in Limine* Seeking Judicial Notice of Federal Government Documents, ECF No. 332 ¶ 7 ("First Rodgers Decl.").

<sup>&</sup>lt;sup>1</sup> Although Defendants list only 22 exhibits to which they have changed their position, Ex. 1 at 2, Plaintiffs have identified two additional unlisted exhibits that are duplicates of exhibits to which Defendants have changed their position. Exhibit 354 is a duplicate of Exhibit 338, to which Defendants have now asserted "no position" rather than an objection. And Exhibit 334 is a duplicate of Exhibit 350, to which Defendants have now asserted "no position" rather than an objection.

- 4. Defendants now do not object to the Court taking judicial notice of 294 documents; take no position on 55 documents; and object to 15 documents on the basis of inadequate foundation. ECF No. 327 at 2; Exhibit 1 at 2.
- 5. Attached as **Exhibit 2** to this Declaration is a revised table listing the 294 documents to which Defendants have raised no objections. Plaintiffs request that this Court take judicial notice of these documents and Defendants do not object. ECF No. 327 at 2 ("Defendants respectfully request that the Court take judicial notice of the existence and authenticity of documents for which Defendants have 'no objection' . . . ."). In Exhibit 2, Plaintiffs have highlighted in yellow the documents that the Defendants previously objected to or took no position on.
- 6. In addition, Plaintiffs have discovered that two of the documents that Defendants did not object to were inadvertently misnumbered in the table submitted to the Court in support of Plaintiffs' Reply Brief (First Rodgers Decl. Ex. 1), as well as in the other versions of the tables submitted to the Court by both parties during the Motion *in Limine* briefing. The numbering of these exhibits, properly Exs. 381 and 386, have been corrected in Exhibit 2 to this Supplemental Declaration, with the corrections indicated in green highlighting on Exhibit 2 and information provided about the need for correction. The numbering in Exhibit 2 to this Supplemental Declaration supersedes numbering in previously submitted tables and the statements made in paragraphs 9 and 10 to the First Rodgers Declaration.
- 7. Excluding documents Plaintiffs withdrew from the Court's consideration for judicial notice, *see* Ex. 2 to First Rodgers Decl., ECF No. 332-1 at 20–22, there are 55 remaining documents to which Defendants take "no position." Plaintiffs provided Defendants with

additional source information on these documents. *See* First Rodgers Decl. ¶ 7. Attached as **Exhibit 3** to my Declaration is a list of these 55 remaining documents, with additional source information provided for the Court's consideration. The documents that the Defendants previously objected to are highlighted in yellow. The Plaintiffs have provided the legal basis for the Court taking judicial notice of these documents in their Reply Brief.

- 8. As to the remaining 15 documents to which Defendants continue to object, Plaintiffs attempted to resolve many of these objections by providing Defendants and the Court with additional information to establish the foundation for each document. *See* First Rodgers Decl. ¶ 7. These documents are listed in **Exhibit 4** to my Declaration. The document to which Defendants newly object is highlighted in yellow. The far right columns contain Defendants' new objections raised after the Reply Brief was filed and Plaintiffs' response to these objections, which demonstrate why it is appropriate for the Court to take judicial notice of these 15 documents as well.
- 9. Changes to one document, Exhibit 311, require additional clarification. The exhibit is highlighted in green in Exhibit 4 to this Supplemental Declaration. In reference to ¶ 9 of the First Rodgers Declaration, stating that "Exhibit 311 to the original Motion in Limine . . . was inadvertently omitted when the original Motion in Limine was filed," Plaintiffs wish to clarify that the document filed as Exhibit 311 to the original Motion in Limine, ECF No. 299-115, was the incorrect document. The document filed as Exhibit 311 was a PDF screenshot of the website where the document was housed. Defendants objected to this exhibit. The correct document—U.S. Army Corps of Eng'rs, Navigation Data Ctr., Ports and Waterways Facilities (Sept. 12, 2011)—is an Excel spreadsheet and

was inadvertently omitted during the initial filing process. Due to its size and file type,

the correct document for Exhibit 311 has been served on Defendants and filed with the

court via USB drive as Exhibit 6 to the First Rodgers Declaration, ECF No. 332-1 at 34,

and should replace the incorrect PDF document filed as Exhibit 311, ECF No. 299-115.

Plaintiffs have also provided an updated link to the spreadsheet in Exhibit 4 to this

Supplemental Declaration, as the previous link no longer directs to the location of the

spreadsheet.

In accordance with 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true

#### Dear Andrea:

We have reviewed your letter of July 30, 2018 regarding your pending motion in limine seeking judicial notice of certain documents, the spreadsheet attached to your July 31, 2018 email, and Plaintiffs' Reply in Support of Motion *in Limine* and supporting declaration, ECF Nos. 331, 332. As indicated in our response to the motion, "Defendants do not object to the Court taking judicial notice of . . . identifiable documents that were created by defendant agencies and are believed by Defendants . . . to be authentic." Defs.' Resp. to Motion in Limine at 2, ECF No. 327. In addition "Defendants take no position as to . . . documents . . . that were not created by agency defendants or [can] not be authenticated by Defendants." *Id.* Lastly, as to "reports, news articles, videos, and scientific articles produced by third parties, as well as documents . . . for which no source is provided, or the source is a third-party website, Plaintiffs have not . . provided an adequate foundation for the Court to take judicial notice." *Id.* It is on this basis that Defendants asked that the Court take judicial notice of "the existence and authenticity of documents for which Defendants have 'no objection,' and that it decline to take judicial notice of documents for which Plaintiffs have not proffered an adequate foundation." *Id.* 

In your reply brief, you misleadingly describe Defendants' position. First, you state that both "Plaintiffs and Defendants respectfully request that the Court take judicial notice of [the no objection] documents for the reasons set forth in Plaintiffs' Motion *in Limine*." Pls.' Reply at 2. This misstates Defendants' positon. To be clear, Defendants have "no objection" to the Court taking judicial notice of documents "that were *created by defendant agencies*" and are "believed by Defendants . . . to be authentic." Defs.' Resp. at 2. In other words, defendant agencies reviewed their own documents, determined that some were authentic, and do not oppose Plaintiffs' motion as to those documents on that basis. Defendants, however, have not joined in

Plaintiffs' motion, and your representation that Defendants request the Court to take judicial notice "for the reasons set forth in Plaintiffs' Motion *in Limine*" is inaccurate.

Second, you state that Defendants objected to documents "on the ground that the documents were 'reports, news articles, videos, and scientific articles produced by third parties as well as documents which are purported to be government documents but for which no source is provided, or the source is a third-party website." Pls.' Reply at 3. Here, you neglect to note that the reason Defendants object to notice of such documents is because "Plaintiffs have not . . . provided an adequate foundation for the Court to take judicial notice." Defs.' Resp. at 2. Providing such a foundation is Plaintiffs' burden, and it is Defendants' position that Plaintiffs have not yet carried that burden.

The foregoing notwithstanding, in light of the additional information provided by Plaintiffs regarding the source of various documents, we have reviewed our previous positions and, applying the same principles set forth in our response brief, adjusted our position on certain documents as follows:

After subtracting the documents for which Plaintiffs no longer seek judicial notice, *see* Decl. of Andrea K. Rodgers ¶ 4, ECF No. 332, and accounting for the changes we propose in the table above, there are now 55 documents as to which the United States takes no position. The United States takes no position on these 55 documents because the documents are not in the possession of, and were not produced by, a government agency that is a party to this lawsuit. Defendants are in no better a position to confirm the authenticity of the documents than

Plaintiffs, whose burden it is to establish that such documents satisfy the standards of Federal Rule of Evidence 201.

In addition, there remain 16 documents for which the United States objects to judicial notice. These consist of the following:

- Five documents to which the United States objected in its response brief and for which Plaintiffs have not provided any additional information to establish authenticity (20, 110, 299, 316, 334). For exhibits 20 and 334, Plaintiffs provide no information about the location of the hard copy document, thereby preventing Defendants, or the Court, from confirming its existence. Exhibits 299 and 316 are the same document and the only source provided is a questionable third party website. The original URL provided by Plaintiffs for exhibit 110 is a questionable third party website and the new URL links to a different document.
- Eight documents for which the URL that Plaintiffs provide fails to link to the relevant document (249, 250, 251, 305, 306, 308, 309, 311). In each of these instances, the URL is either broken or links to a website different from the document that Plaintiffs seek to have judicially noticed. Thus, Plaintiffs have not provided adequate foundational information to justify judicial notice. Defendants note that Plaintiffs have also provided no foundation for the spreadsheet that they provided by email on August 8, 2018 as exhibit 311. The URL for exhibit 311 does not link to the spreadsheet, and Plaintiffs provide no explanation of where and how they located the spreadsheet.
- Two documents for which Plaintiffs have provided a URL that links to a video recording by a third party on a third party website (100, 102). Because the URL provides no information about the source of the video or whether and how it has been edited, there is insufficient foundation for the videos.
- One document which is a court decision (295). Federal Rule of Evidence 201 provides for judicial notice of "adjudicative facts." Fed. R. Evid. 201. Adjudicative facts are "the facts of the particular case," as compared to "legislative facts" which involve "legal reasoning and the lawmaking process." Fed. R. Evid. 201, advisory comm. note. Because court decisions go to legal reasoning rather than the facts of this case, they are not appropriate for judicial notice. See, e.g., Lemieux v. Cwalt, Inc., No. CV 15-77-BU-JCL, 2017 WL 365481, at \*1 (D. Mont. Jan. 25, 2017) ("[B]ecause these statutes, cases, and regulations are 'legislative facts' rather than 'adjudicative facts,' they are not appropriate for judicial notice."); Blye v. Cal. Supreme Court, No. CV 11-5046-DWM, 2014 WL 295022, at \*1 (N.D. Cal. Jan. 21, 2014) (refusing to take judicial notice of Supreme Court decision because the existence of that decision does not "meet[] the test for relevant evidence set forth by the Rules of Evidence").

In sum, as noted in our response brief, Defendants do not object to the Court taking judicial notice of the existence and authenticity of documents to which Defendants have "no objection." Defendants take no position as to documents whose authenticity they have not confirmed, and it remains Plaintiffs burden under Federal Rule of Evidence 201 to establish that

the existence and authenticity of such documents is "generally known" or "can be accurately and readily determined from sources whose accuracy cannot reasonably be questioned." Defendants maintain that it would not be appropriate for the Court to take judicial notice of the existence and authenticity of documents for which Plaintiffs have not provided an adequate foundation.

As to the 16 documents to which Defendants object, Defendants remain available to meet and confer if Plaintiffs believe they can provide an adequate foundation. In any event, Plaintiffs should revise their reply so as to correct the inaccuracies identified in this letter and to apprise the Court of the parties' respective positions in light of the additional information that Plaintiffs provided.
