A. Where did the events giving rise to your claim(s) occur?

Limiting emissions which become aerosols in the atmosphere causes Global Warming which is damaging worldwide. Prior to 1990 there was global cooling with many aerosols in the atmosphere and as they were restricted we reached what most people consider a normal global temperature. If all post 1990 air restrictions which do not pertain substances poisonous to humans are eliminated the atmospheric temperature will quickly cool to 1990 levels. Letting the aerosols increase back to the 1990 level will not be perceptible but will make a big difference in global warming.
