NOTICE OF WITHDRAWAL OF INSTITUTIONAL PLAINTIFFS' MOTION TO INTERVENE FOR THE LIMITED PURPOSE OF OBJECTING TO DEFENDANTS' REQUEST FOR DISMISSAL WITH PREJUDICE

Exxon shareholders the Saratoga Advantage Trust Energy & Basic Materials Portfolio and the City of Birmingham Retirement and Relief System ("Proposed Intervenors"), hereby withdraw their Motion to Intervene for the Limited Purpose of Objecting to Defendants' Request for Dismissal with Prejudice (the "Motion to Intervene," Dkt. No. 61). On September 15, 2020, the Honorable Steven C. Mannion ordered that Proposed Intervenors' related derivative action brought on behalf of Nominal Defendant Exxon in the District of New Jersey be transferred to the Northern District of Texas. *See In re Exxon Mobil Corporation Derivative Litigation*, Civil Action No. 2:19-cv-16380 (D. N.J.), Dkt No. 65. Accordingly, Proposed Intervenors will become party to the above-captioned proceedings pursuant to this Court's August 6, 2019 consolidation order, rendering intervention superfluous. *See* Dkt. No. 11 at ¶11. The parties to the present action have indicated that they do not oppose the withdrawal of Proposed Intervenors' Motion to Intervene.
