Dkt. 347. The Court has considered the Mandate, the remaining record and is 20 fully advised. 21 This case challenged the State's denial of a Clean Water Act Section 401 Certification 22 and denial of request for approval of a sublease of state-owned aquatic lands for Plaintiffs' 23 proposed coal export terminal. Dkt. 1. 24

ORDER - 1

On October 23, 2018, the Defendants' motion for partial summary judgment was granted and all claims against Defendant Hilary Franz were dismissed as barred by the Eleventh Amendment. Dkt. 170. On December 11, 2018, Defendants' motion for partial summary judgment was granted and the Plaintiffs' preemption claims under the Interstate Commerce Commission Termination Act and the Ports and Waterways Safety Act were dismissed. Dkt. 200. On April 11, 2019, the undersigned determined that temporary abstention was appropriate, and the case was stayed pursuant to *Railroad Commission of Texas v. Pullman*, 312 U.S. 496 (1941). Dkt. 326. The Plaintiffs filed notices of appeal of those orders. Dkts. 329 and 331.

Plaintiff Lighthouse Resources Inc. filed for bankruptcy relief in December 2020; an unopposed motion to dismiss the appeal as moot was filed by the Defendants. Dkt. 342. The Ninth Circuit Court of Appeals granted the motion and dismissed the appeal. *Id.* The Mandate issued on April 14, 2021. Dkt. 347.

It is unclear what remains in this case. Accordingly, by **April 30, 2021**, the parties are ordered to file a joint status report explaining what issues, if any, remain in this case, and whether the stay should now be lifted.
