Pursuant to the Court’s Order on March 15, 2022, Plaintiffs, Federal Defendants, and Intervenor-jointly submit the following status report regarding their positions on the mootness of Federal Defendants’ pending Motion to Remand (Remand Motion), ECF No. 200.

**Joint Statement of Plaintiffs and Federal Defendants**

Federal Defendants’ pending Remand Motion is not presently moot, but will become moot should the Court grant Plaintiffs’ pending Motion to Dismiss Voluntarily, ECF No. 227.

**Joint Statement of Intervenor American Petroleum Institute, State of Wyoming, State of Utah, and Western Energy Alliance**

Intervenor-Defendants agree that Federal Defendants’ pending Remand Motion will become moot if the Court grant’s Plaintiffs’ pending Motion to Dismiss Voluntarily. That said, Intervenor-Defendant American Petroleum Institute (“API”) has filed oppositions to Federal Defendants’ Remand Motion and Plaintiffs’ Motion to Dismiss Voluntarily. Instead, as explained in those oppositions, the Court should first resolve API’s motions to dismiss Plaintiffs’ claims, in whole or in part.
