PETITION FOR REVIEW

Pembroke Environmental Justice Coalition, Blacks in Green, Green Power Alliance and Environmental Defense Fund (“PEJC *et al.*”) hereby petition the court for review of the January 5, 2022 Order of the Illinois Commerce Commission (“ICC” or “Commission”) in *Northern Illinois Gas Company d/b/a Nicor Gas Company Application for permanent Certificate of Public Convenience and Necessity to construct, operate, and maintain gas distribution facilities and to transact the business of furnishing gas service to the public in Kankakee County, Illinois*, ICC Docket 21-0698, and the February 17, 2022 denial of PEJC *et al.*’s Application for Rehearing. PEJC *et al.* make this petition pursuant to Illinois Supreme Court Rule 335, 220 ILCS 5/10-201 and Ill. Admin. Code § 200.890. PEJC *et al.* seek relief reversing the above orders, and remanding this matter to the Commission for appropriate further proceedings and the entry of an appropriate order on remand, including any applicable refund owed to ratepayers, in accordance with the Court’s judgment.


