1. On May 26, 2022, the Federal Energy Regulatory Commission denied by operation of law the rehearing petition filed by the Niskanen Center and certain affected landowners and landowner organizations. *Atlantic Coast Pipeline, LLC*, 179 FERC ¶ 62,108 (May 26, 2022).

The Niskanen Center and affected landowners and landowner
organizations petitioned for review of the Commission's Restoration Order on June
23, 2022. This Court docketed the petition for review as *Johnson v. FERC*, No.
22-1120 (D.C. Cir.) on June 24.

3. The Commission on July 28, 2022 issued an order on rehearing generally rejecting the arguments made in the Niskanen Center rehearing petition but added one additional environmental condition to the Restoration Order. *Atlantic Coast Pipeline, LLC*, 180 FERC ¶ 61,059 (July 28, 2022).

Transmission and Storage (BHE GT&S) Company. Dominion Energy Transmission, Inc. has changed its name to Eastern Gas Transmission and Storage, Inc. 4. The parties accordingly request that these petitions for review remain

in abeyance.
