4 If the Court remands without vacatur, the U.S. Fish and Wildlife Service and
5 National Marine Fisheries Service anticipate submitting proposed regulations to
6 the Office of Management and Budget in early February 2023, to the Federal
7 Register in mid-May 2023, and if the proposed regulations are published on that
