WHEREAS, on May 8, 2023, Respondent sent letters to all parties notifying them that: (1) the permits to drill the Placerita wells at issue in the petition have been rescinded (letter attached hereto as Exhibit 2), (2) the permits to drill the Elk Hills wells at issue in the petition have been cancelled (letter attached hereto as Exhibit 3), and (3) that the associated determinations made pursuant to the California Environmental Quality Act for both sets of wells are void;

WHEREAS, rescinding the approvals for the Placerita wells and canceling the Elk Hills wells renders the Petition for Writ of Mandate moot;

WHEREAS, Petitioner has agreed to dismiss this action, with prejudice;

WHEREAS, the Parties agree that dismissal of this action does not prevent Petitioner from filing a motion to recover reasonable costs and attorneys' fees and that this Court shall retain jurisdiction for the purposes of resolving Petitioner's claims for costs and attorneys' fees.

Any action to drill the above-referenced NOIs is no longer approved by CaIGEM.

The above-referenced NOIs were approved by the State Oil and Gas Supervisor on November 2, 2022, and November 16, 2022, respectively. Subsequent litigation (Alameda County Superior Court, Case No. 22CV023134) was initiated by Center for Biological Diversity (CBD) against both Shadow Wolf and CalGEM, asserting (in part) that the environmental review under the CEQA was inadequate in connection with above-referenced NOIs, and other approvals.

Although CalGEM does not necessarily agree that the CEQA review was inadequate, the approvals are not consistent with CalGEM's current practices. Consistent with

CalGEM's mission to protect public health and safety while safeguarding the environment, CalGEM believes that further analysis must take place before the wells can be used for oil and gas extraction.


