State Defendants respectfully request that the Court strike its earlier-filed 1 2 Motion to Dismiss the Complaint, filed on behalf of the State Building Code Council (SBCC). See ECF No. 38. 3 After the motion to dismiss was filed, Plaintiffs filed the First Amended 4 5 Complaint, adding the individual members of the SBCC as named defendants and seeking injunctive relief against them in their official capacities. ECF No. 6 7 47. Because the First Amended Complaint is now the operative complaint, the earlier Motion to Dismiss the original Complaint is moot. Lacey v. Maricopa 8 9 Cnty., 693 F.3d 896, 927 (9th Cir. 2012) (en banc) ("[T]he general rule is that an 10 amended complaint super[s]edes the original complaint and renders it without 11 legal effect."). State Defendants previously filed a notice striking the Motion to 12 Dismiss, see ECF No. 50, but were instructed by chambers to instead file a 13 motion to strike. The Court should therefore grant State Defendants' motion and strike 14 15 Defendant SBCC's Motion to Dismiss, ECF No. 38.
